Wedding Package

Lake Kivu, Rwanda

Thank you for considering Rushel Kivu Resort for your wedding. This package sets out our accommodation, catering and beverage options, along with our payment and cancellation terms. Once you have selected your options and both parties sign, this document serves as your wedding agreement with Rushel Kivu Resort.

1. Accommodation Packages

Rushel Kivu Resort has 15 rooms (9 in the East Wing, 6 in the West Wing), priced at 175,000 RWF per night, double occupancy, inclusive of breakfast. Our 3 large safari tents with private bathrooms are available separately as optional add-ons (see Section 1c).

Package 1 — Full Exclusive

All 15 rooms are booked exclusively for the wedding party for 2 nights. No outside guests are accommodated during this period.

Package 2 — Exclusive with Guest Self-Booking

The couple guarantees the East Wing (9 rooms) for 2 nights. The West Wing (6 rooms) is released for the couple's guests to self-book directly with our reservations office at the same wedding rate, up to 15 days before the wedding date. The resort remains fully exclusive to the wedding party for the duration, whether or not the released rooms are fully booked.

Guaranteed block (couple)	9 rooms (East Wing)
Duration	2 nights
Self-booking block (guests)	6 rooms (West Wing), cutoff 15 days before wedding
Venue hire	1,000,000 RWF (applies regardless of self-booking fill)
Exclusivity	Guaranteed
Couple's minimum commitment	4,150,000 RWF

Note: guests booking into the self-booking block pay Rushel directly at 175,000 RWF/night and are not part of the couple's invoice.

1c. Optional Add-on — Safari Tents

3 large safari tents with private bathrooms are available as an optional add-on to either package, at 130,000 RWF per tent per night, subject to availability.

2. Catering Packages

Priced per guest. Our head chef will finalize menu specifics with the couple ahead of the wedding date.

3. Beverage Packages

Suggested beverage combinations by guest count, based on realistic crate quantities rather than a straight per-guest multiplier. Combinations can be adjusted to the couple's preference.

Corkage: the wedding party may bring up to 15 outside bottles at no charge. Beyond this: 14,000 RWF/bottle (wine), 27,000 RWF/bottle (liquor), 43,000 RWF/bottle (champagne & premium liquor).

4. Payment Terms

All payment stages are calculated relative to the wedding date.

Stage	Amount Due	Due Date
Deposit	30% of accommodation	At signing
Second payment	30% of accommodation	6 months before wedding
Final payment	Remaining 40% of accommodation + 100% of catering & beverage	30 days before wedding

Final guest numbers must be confirmed no later than 30 days before the wedding date. Payments made prior to this date are applied toward the confirmed total.

5. Cancellation Terms

Notice Before Wedding Date	Charge
120+ days	No charge
90 days	25% of accommodation
60 days	50% of accommodation
30 days	75% of accommodation
15 days	100% of accommodation + 50% of catering

Any amount paid beyond the applicable charge is refunded to the couple within 14 days of cancellation.

Acts of God: if an event beyond either party's control prevents the wedding from taking place as scheduled, the couple may reschedule within 12 months, subject to availability, at no additional penalty. Deposits already paid are carried forward as credit toward the new date and are not refunded in cash.
